# INSTRUMENT OF DELEGATION FOR PART OF MORNING STAR BEACH RECREATION RESERVE

- 1. <u>PURSUANT</u> to section 10 of the Reserves Act 1977 I, <u>WILLOW-JEAN PRIME</u> Minister of Conservation, <u>DELEGATE</u> to TE RŪNANGA O NGĀI TAHU such of my powers, functions and duties under the Reserves Act 1977 as are set out in the following Schedule subject to the Limitation of Powers in the Schedule and to the conditions in paragraphs 2, 3, 4 and 5 of this Instrument.
- 2. The delegations in this Instrument apply only in respect of that part of the Morning Star Beach Recreation Reserve defined as Section 5 on Survey Office Plan 587344, being 0.8025ha (the "Reserve") and only while Te Rūnanga o Ngāi Tahu are the administering body of the Reserve by virtue of a vesting or an appointment to control and manage.
- 3. When exercising the delegations in this Instrument, TE RŪNANGA O NGĀI TAHU must comply with the Morning Star Reserve Conflict Management Plan dated 11 October 2023 (the "CMP"). The CMP is not to be amended without the prior approval of the Department of Conservation.
- 4. This Instrument and the CMP will be made available to the public on the TE RŪNANGA O NGĀI TAHU website.
- 5. The delegations in this Instrument are only exercisable if TE RŪNANGA O NGĀI TAHU, as the administering body of the Reserve, has complied with the conditions of vesting imposed when the Reserve was vested in TE RŪNANGA O NGĀI TAHU.

#### Definitions:

"Te Rūnanga o Ngāi Tahu" means the body corporate incorporated by section 6 Te Rūnanga o Ngāi Tahu Act 1996
