Pūtea Manaaki Emergency Relief Fund



Purpose of this fund

The purpose of the Pūtea Manaaki Emergency Relief Fund is to provide assistance to Ngāi Tahu whānui members registered with Te Rūnanga o Ngāi Tahu who have been directly affected following a natural disaster emergency. These are for expenses associated with responding to the event and not for items normally covered by insurance.

This Pūtea Manaaki Emergency Grant is <u>open from 22nd December 2023 to 31 January 2024.</u> The closure date will be reviewed based on funding availability and may vary depending on funding levels and level of demand for support. We will review these applications and come back to you as soon as possible.

Criteria for Pūtea Manaaki Emergency Relief Funding

This grant is for emergency expenses to provide support for whānau who have been directly affected by the event. It does not cover costs for items that are normally covered by insurance. Te Rūnanga o Ngāi Tahu staff may contact you to get further information and/or proof of expense

- Applicants must be registered with Te Rūnanga o Ngāi Tahu
- Only ONE application per household will be accepted.
- Only applications received using this form will be processed.
- Proof of identity (e.g. Drivers Licence, Passport, Community Services Card) must be provided with all
 applications.
- Proof of residential address (e.g. copy of power, phone account, bank statement) must be provided with all applications.
- Proof of bank account details (e.g. deposit slip, bank statement) in the name of the applicant must be provided with all applications.
- Applicants must provide a brief explanation of how they and their whānau have been directly affected by the emergency event, for example:
 - · You have been evacuated from your home;
 - Your primary family home was damaged or lost (note, funds are not available in respect of damage to holiday homes / baches or investment properties); or
 - You were in the area at the time of the emergency and have incurred costs as a consequence.

Important information

The Pūtea Manaaki - Emergency Relief Fund is available at the sole discretion of Te Rūnanga o Ngāi Tahu. Funds are limited; some applications may not be granted. Because funding is limited, a decision on the final grant amount will be determined after the grant close date and all the applications have been received.
