

# Pūtea Manaaki Emergency Relief Fund

## Purpose of this fund

The purpose of the Pūtea Manaaki Emergency Relief Fund is to provide assistance to Ngāi Tahu whānui members registered with Te Rūnanga o Ngāi Tahu who have been directly affected following the New South Wales Floods - November 2022.

## Criteria for Pūtea Manaaki Emergency Relief Funding

- Applicants must be registered with Te Rūnanga o Ngāi Tahu.
- Only ONE application per household will be accepted.
- Only applications received using this form will be processed.
- Proof of identity (e.g. Drivers Licence, Passport) must be provided with all applications.
- Proof of residential address (e.g. copy of power, phone account, bank statement) must be provided with all applications.
- Proof of bank account details (e.g. deposit slip, bank statement) in the name of the applicant must be provided with all applications. The SWIFT code must also be provided.
- Applicants must provide a brief explanation of how they and their whānau have been directly affected by the emergency event, for example:
  - You have been evacuated from your home;
  - your primary family home was damaged or lost (note, funds are not available in respect of damage to holiday homes / baches or investment properties); or
  - you were in the area at the time of the emergency and have incurred costs as a consequence.

## Important information

The Pūtea Manaaki - Emergency Relief Fund is available at the sole discretion of Te Rūnanga o Ngāi Tahu. Funds are limited; some applications may not be granted. Decisions on the grant of funding will be made in accordance with relevant Te Rūnanga o Ngāi Tahu policy. The maximum amount that will be awarded in any case is A\$500.
